## DISCERNING GOD'S RESOLUTIONS

A new year brings new possibilities and new beginnings. Sometimes we express those in terms of *resolutions*, as if turning to that first page of a new calendar means a clean slate for becoming the person I've always wanted to be. And sometimes it turns out that way. But I must confess that I usually resemble those people who drive gym attendance way up in January before it comes back to normal in February. The calendar may have changed, but my resolve, my will-power hasn't.

But what about God's "resolutions" this year? The easy part of our new year's resolutions is making them. In contrast, we pray "Thy will be done" all the time, trusting that God always keeps God's promises—we just don't always know God's will, God's resolutions *for us*. What if this January we spent more time thinking about God's resolutions in our lives?

There's a word for thinking about God's will: *discernment*. Especially as someone who came recently to a vocation in the church, I've heard the word "discernment" thrown around a lot. The ELCA's unofficial book for people considering ministry is subtitled "Discerning God's Call to Ministry." I have heard everyone from church councils to those taking the next steps after a job loss to engage in a "process of discernment" as they consider the future. Sometimes the word comes with a description, but often, it seems, understanding what is meant by "discernment" is left to the reader or hearer. Moreover, unlike many other "churchy" words like "righteousness," "discernment" does not correspond to a particular word in the original languages of scripture. So what does discernment mean? And what *should* it mean for us?

Perhaps "discernment" has become a popular word simply because it is better than the alternatives. Since it seems to refer to a reality or a will beyond our own, it is not mere "decision-making." Nor is it "divination," as though discernment were a supernatural trick to reveal hidden things with clear certainty. Talking about "discernment" seems to capture our situation of wanting to listen to the will of God, but feeling uncertain about what that is. Even if we use the right word, forgetting the sense it carries of listening amid uncertainty puts us at risk of mistaking our own desires for God's will.

But is uncertainty about God's will really our biggest problem when it comes to discernment? Often discernment is most called for in the midst of tumultuous times in our lives, whether those times involve considering new directions for a congregation, new career paths, or treatment options for a terminal illness. Especially in such times, the question of God's will is not just about knowledge or uncertainty: it is about fear and trust. When I wonder what God's will for me might be, it is never a matter of idle curiosity; ultimately, it is a matter of meaning or emptiness, of joy or despair, of life or death. In these times, especially when God seems absent, the questions of our hearts may sound less like pious talk of "discernment" and more like the words of psalms: "How long, O LORD? Will you hide yourself forever?" (Psalm 89:46); "Do not forsake me, O LORD; O my God, do not be far from me" (Psalm 38:21).

The object of our discernment is finally, then, not God's will, as though knowing that will were the chief obstacle to obeying it. Rather, our discernment is of our relationship with God. God's will is your salvation and life in your crucified and risen Lord, Jesus Christ, love incarnate. In the uncertain, fearful places in your life, do you trust your Lord to lead you, as a popular prayer puts it, "to ventures of which we cannot see the ending, by paths as yet untrodden, through perils unknown"? Can we trust Christ to lead us out of our "comfort zone" and transform us? In the end, as Paul suggests to the Romans, true discernment begins not with us figuring out *God's* will, but with God transforming *us* in faith: "Do not be conformed to this world, but be transformed by the renewing of your minds, so that you may discern what is the will of God— what is good and acceptable and perfect" (Romans 12:2). That's a resolution we can give thanks for year-round.

Dear Friends in Christ,

As you know, Bishop Wollersheim will be retiring August 31, 2016. We plan to honor Bishop Gary at our Synod Assembly thanking him for the 18 great years of leadership as bishop in the Northern Illinois Synod.

One of the ways we wish to honor and say "thank you" to Bishop Gary and Polly is by establishing two ongoing ministry funds in their names. To this end, we have renamed the "Rostered Leaders Debt Retirement Fund" the "Gary Wollersheim Rostered Leaders Educational Debt Retirement Fund," and have established a new fund, the "Polly Wollersheim Fund for Literacy Education - Arcot Lutheran Church, India," to help increase literacy in our Companion Synod. With this letter, you will find a description of the two funds sharing how they can make a difference and have a lasting impact in our Northern Illinois Synod and globally in the Arcot Lutheran Church, India. Making a gift to one or both of these funds would be a wonderful way to say "thank you" to the Wollersheims for their many years of service in the church and specifically in our Northern Illinois Synod.

There are a number of different ways that you and your congregation can participate in sharing a gift to these funds.

- You can spread the news of the two funds as a thank you to the Wollersheims inviting individual gifts from people in your congregation.
- A Sunday could be designated when gifts can be received to provide a congregational gift to the funds.
- If your congregation has an endowment fund, a portion of the interest might be designated for the funds.
- The Advent or Lenten offering could be designated for your congregational gift.
- The celebration of congregational anniversaries can also be a time to share a special gift to one or both of these important funds.

Whichever way or combination of ways for receiving gifts works for your congregation, the gifts you share will be a wonderful way to leave a meaningful legacy to the faithfulness and leadership of Bishop Gary and Polly. Please know, too, that these funds will be ongoing and gifts can be received for these funds at any time beginning now and well into the future.

We will be receiving gifts for these funds at the synod office. When you send your gift, please designate which fund and the amount for each. We will announce the gifts total to date for each fund at our Synod Assembly in June.

Thank you for your prayerful consideration of this lasting way to acknowledge the faithful leadership of Bishop Wollersheim and to say thank you for his faithful service to Christ and the Church over these many years.
